NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors that Sonoma County Sheriff-Coroner, Bill Cogbill, is authorized to execute the California State Department of Boating and Waterways Equipment and Operation contract documents and requests for reimbursement up to \$35,000.
