

**NOTICE OF PUBLIC HEARINGS
BY SONOMA LOCAL AGENCY FORMATION COMMISSION**

NOTICE IS HEREBY GIVEN that the Sonoma Local Agency Formation Commission (the Commission) will consider the following:

1. File No. 07-04: Amendment No. 5 to the City of Santa Rosa Sphere of Influence and Reorganization No. 05-03 (Suard) Involving Annexation to the City of Santa Rosa and Detachment from Rincon Valley Fire Protection District and County Service Area No. 41 (Multi-Services). The application was initiated by petition by Victor Suard. The affected territory, consisting of one parcel, is generally located east of Calistoga Road and south of Badger Road in northeast Santa Rosa. Acres: 14.22+/- . A negative declaration has been adopted by the City of Santa Rosa for the project, pursuant to the California Environmental Quality Act.
2. Fiscal Year 2007-08 LAFCO Proposed Budget and Fee Schedule

The Commission will hold public hearings at or after 2:00 p.m. on April 4, 2007, in the Sonoma County Administration Building, 575 Administration Drive, Room 102A, Santa Rosa, California, on the request for amendment to the sphere of influence of the City of Santa Rosa, the reorganization proposal and the FY 2006-07 LAFCO Proposed Budget and Fee Schedule. At the hearings, the Commission will hear and receive any relevant oral and written testimony and evidence presented or filed concerning the sphere of influence amendment, the reorganization proposal, and the proposed budget and fee schedule. The Commission will consider the report of the Executive Officer on the sphere of influence amendment and reorganization proposal, the plan for providing services, and the environmental effects of the proposal, as shown in the negative declaration. The Commission will consider the report of the Executive Officer and may accept or amend the FY 2006-07 Proposed Budget and Fee Schedule.

Copies of all documents relating to the named proposal and the proposed budget and fee schedule are on file and may be reviewed at the Sonoma Local Agency Formation Commission office. If you cannot attend the public hearings described in this notice, you may submit written comments prior to the hearings. If you challenge the actions of the Commission in court on the sphere of influence amendment, the negative declaration, and the proposal, or on the proposed budget and fee schedule, you may be limited to raising only those issues raised at the public hearings described in this notice, or in written correspondence delivered to the Commission at, or prior to, the hearing.

ALL INTERESTED PERSONS ARE HEREBY INVITED TO BE PRESENT AND HEARD ON THE MATTERS DESCRIBED IN THIS NOTICE.
