

**NOTICE OF PUBLIC HEARING
BY SONOMA LOCAL AGENCY FORMATION COMMISSION**

NOTICE IS HEREBY GIVEN that the Sonoma Local Agency Formation Commission (“the Commission”) will consider the following:

1. Confirmation of Sphere of Influence for Southern Sonoma County Resource Conservation District (“the Sphere of Influence Confirmation”).
2. File No. 08-04: Annexation No. 2008-01 to the Southern Sonoma County Resource Conservation District (“the District”) of Territory Adjacent to the District (“the Annexation Proposal”).

The Sphere of Influence Confirmation was initiated by the Commission and is exempt from the California Environmental Quality Act (“CEQA”) pursuant to Section 15061(b)(3) of the State CEQA Guidelines.

The Annexation Proposal was initiated by resolution of the Board of Directors of the District. The affected territory is inclusive of parcels totaling 920 acres +/- generally located in six Tax Rate Areas in the southwest area of the city of Petaluma, west of U.S. Highway 101. The proposal is exempt from CEQA pursuant to Section 15319 of the State CEQA Guidelines.

The Commission will conduct a public hearing at or after 2:00 p.m. on June 4, 2008, in the Sonoma County Administration Building, 575 Administration Drive, Room 102A, Santa Rosa, California, 95403 on the Sphere of Influence Confirmation and Annexation Proposal. At the hearing, the Commission will hear and receive any relevant oral and written testimony and evidence presented or filed concerning the Sphere of Influence Confirmation and Annexation Proposal. The Commission will consider the report of the Executive Officer on the two matters.

Copies of all documents relating to the Sphere of Influence Confirmation and Annexation Proposal are on file and may be reviewed at the Sonoma Local Agency Formation Commission office. If you cannot attend the public hearing described in this notice, you may submit written comments prior to the hearing. Please direct comments, questions, and requests to review documents to the Sonoma Local Agency Formation Commission, 575 Administration Drive, Room 104A, Santa Rosa, California, 95403, (707) 565-2577.

If you challenge the actions of the Commission on the exemptions from CEQA and/or the proposals in court, you and/or others may be limited to raising only those issues raised at the public hearing described in this notice, or in written correspondence delivered to the Sonoma Local Agency Formation Commission at, or prior to, the hearing.
